**DEADLINE TO APPLY: 30 days prior to a KSLS Charitable Foundation Board meeting in
January, April, July & October.**

HOW TO APPLY:

Complete an Application for Scholarship and include the following information:

1. A statement indicating education objectives, future plans of study or research, professional activities and financial need. This needs to include the targeted completion of the education program.
2. Two letters of recommendation (at least one from a faculty member familiar with the student's work).
3. A complete original official transcript through the end of the school year prior to when the scholarship will be presented and proof of enrollment for the current semester.

ELIGIBILITY: The applicant must be enrolled in an accredited technical school, college or university with the express intention of obtaining a degree suitable to perform land surveying activities. In order to be eligible for a second semester payment the applicant must maintain a GPA of 3.0 or better.

SELECTION CRITERIA: The Student's application will be weighted by the following criteria: 30% for academic record, 30% on the Statement of Education Objectives, 20% on Letter of Recommendation, and 20% on Professional Activities. Membership in a State Surveying Society or NSPS will add points under the Professional Activities category. Degree of financial need will be considered, if needed to break ties. Applicant will be interviewed by local Chapter of KSLS.

NOTIFICATION: Selected recipients will be notified by mail and the check will be presented to a recipient by the local Chapter of KSLS.
